**CALL TO ORDER AND PLEDGE OF ALLEGIANCE**

President Hagman called the meeting to order at 12:17 p.m. and asked Regional Council Member Frank Yokoyama, Cerritos, District 23, to lead the pledge of allegiance.

**PUBLIC COMMENT PERIOD**

President Hagman opened the Public Comment Period for persons to comment on any matter pertinent to SCAG's jurisdiction that were not listed on the agenda.

Board Counsel Duran acknowledged there were no public comments before or after the 5:00 p.m. deadline.

Seeing no public comment speakers for items not listed on the agenda, President Hagman closed the Public Comment Period.

Board Counsel Duran noted that Mayor Frank Navarro from the City of Colton was participating through an accommodation under the Americans with Disabilities Act, and noted that under the Brown Act, Mayor Navarro was required to have his video active during the meeting.

**REVIEW AND PRIORITIZE AGENDA ITEMS**

Before the report on Item No. 1, President Hagman noted they would take one vote on action Item No. 1 and the Consent Calendar.

**CHAIR'S REPORT**

Rocky Rhodes, Community, Economy and Human Development Committee (CEHD) Vice Chair, reported that they held an election for the Chair and Vice Chair positions of the Committee. He shared that both David J. Shapiro and him were elected as Chair and Vice Chair, respectively. He noted that the Committee welcomed three new committee members: Debbie Baker (La Palma), John Grass (Brawley), and Joe Baca (Rialto). He also reported the Committee heard an information item related to home hardening, featuring two speakers. First, Elizabeth Christy, the Education Program Manager at the U.S. Green Building Council, who presented on best practices and resources on home hardening and other important resilience strategies. The second speaker was Brian Cameron, the President of EPIC Calabasas, who spoke on local home hardening strategies and how they support communities with preparation, prevention, and what should be done if disaster occurs.

There were no comments on the CEHD Chair report.

Jenny Crosswhite, Energy and Environment Committee (EEC) Chair, reported that at the EEC they had two information items. The first item consisted of an overview of components and requirements of safety elements with a resilience focus as well as a presentation from the City of Arcadia on their recently completed Safety Element. She also reported they received a presentation from the South Coast AQMD on proposed rules focused on limiting NOx emissions from residential-sized space heaters and water heaters. She noted that they held an election with Rick Denison and Daniel Ramos being selected as Chair and Vice-Chair, respectively. Lastly, she also thanked Vice Chair Meister for her service.

There were no comments on the EEC Chair report.

Tim Sandoval, Transportation Committee (TC) Chair, reported that last month the Transportation Committee recommended approval of the 2025 Regional Active Transportation Program to the Regional Council, which includes \$35 million to support 15 projects and another \$972 million for 113 contingency projects – all of which support walking, bicycling, and other forms of active transportation in the region. He also reported that the Committee took action to appoint a new Chair and Vice Chair to the Committee. He noted that Mike Judge from Simi Valley representing the Ventura County Transportation Commission was appointed Chair of the committee and Thomas Wong, Monterey Park, was appointed to the position of Vice Chair. He also reported that the Committee received three informational presentations. He indicated they continued their discussion on Regional Recovery and Resilience, with a presentation from the San Bernardino County Transportation Authority on their planning efforts. They also received a presentation from the City of Pasadena—focused on how transit was instrumental in evacuating vulnerable populations that have mobility challenges. Lastly, they received a staff presentation on the Last Mile Freight Program (LMFP) and preliminary findings from their work to date.

There were no comments on the TC Chair report.

With respect to Item No. 4 on the agenda, President Hagman reported he was a member of the South Coast Air Management Quality District (SCAQMD) and noted for the record that he did not have a financial interest. Regional Council Member Patricia Lock Dawson also acknowledged she was a member and did not have a financial interest.

### **ACTION ITEM**

#### **1. Nomination and Election of 2025-26 SCAG Officer Positions**

Ruben Duran, Board Counsel, reported that pursuant to SCAG's Bylaws, the Nominating Committee met to consider nominations for SCAG's proposed officers for the upcoming year. He noted that the

Committee unanimously voted to recommend to the Regional Council Honorable Cindy Allen, Long Beach, as President; the Honorable Ray Marquez, City of Chino Hills, as 1<sup>st</sup> Vice President; and the Honorable Jenny Crosswhite, Santa Paula, as 2<sup>nd</sup> Vice President. He explained that the process required that the Regional Council vote on that and then it would go to the General Assembly for ratification next month in Palm Desert.

There were no Public Comments on Item 1.

### **INFORMATION ITEM**

#### **13. Presidential Priorities: Goods Movement and Clean Technology**

Kome Ajise, Executive Director, thanked President Hagman for his leadership and noted that this year's EAC Work Plan was committed to continuing their focus on emerging technologies across all policy areas, including more dialogue and information sharing during Regional Council meetings. He highlighted that in the agenda packet they had included a summary Presidential Priorities Report, which provides an overview of the accomplishments over the fiscal year—focused not only on goods movement, but on clean and emerging technologies more generally, as well as transit recovery. He explained that they would feature a discussion on the importance and continued need for the advancement of clean technologies in goods movement infrastructure. He reported that the Regional Council adopted the Clean Transportation Technology Policy and Resolution on April 6, 2023, to define clean transportation technology as zero- and near-zero emission vehicles (ZEV and NZEV, respectively), their supporting infrastructure, and other supporting products that reduce environmental impact over their life cycle. He emphasized that SCAG has led regionally significant efforts to advance the transition to clean transportation technology within goods movement, including the LMFP and the Zero-Emission Truck Infrastructure Study. He noted that with approval of the CPRG grant they could further invest in these technologies for their region.

Executive Director Ajise briefly took a moment to highlight the LMFP and its progress. He explained that the program has gathered valuable information on operational performance, return on investment, and policy hurdles. He noted that SCAG plans to complete the closeout and gather data for the remaining projects and will continue to leverage the program to support their upcoming Comprehensive Sustainable Freight Plan and the Freight TDM Strategy and Implementation Plan.

President Hagman emphasized the importance of technology and governance, and the need for clean transportation and clean technology to meet statutory goals. He highlighted the need for infrastructure planning to support new technologies. He proceeded to moderate the discussion with the panelists.

Joost de Vries, Chief Executive Officer of ZM Trucks, and Matt Petersen, President and Chief Executive Officer of the Los Angeles Cleantech Incubator, discussed their companies' work in hydrogen and battery electric commercial vehicles and buses. They emphasized the importance of local and regional leadership in moving towards new technologies, and the need for more financial incentives and regulatory support. The discussion focused on the transition to electric vehicles in Southern California, particularly for medium and heavy-duty vehicles. The panelists emphasize the maturity of electric vehicle technology and the need for charging infrastructure.

Regional Council Members engaged the panelist in discussion about workforce development opportunities in the electric vehicle industry and addressed concerns about the transition's impact on small businesses and emergency vehicles. The conversation also touched on the evolving safety of electric vehicle batteries and the importance of a methodical approach to implementation.

#### 14. Legislative Update

Kevin Gilhooley, Legislation Manager, provided a legislative update. He noted that 2,500 bills had been introduced in Sacramento, with many amended and undergoing reviews. He reported that the Sacramento Summit was successful, with meetings with elected officials and agency leadership. He shared that the Governor's May Revise was upcoming, and discussions on a potential housing bond were ongoing. With respect to Washington, DC, he reported Congress had been focused on government funding and Republican-led Reconciliation bills. He shared that the Government was now funded through the end of the current fiscal year, and Republicans were turning their attention to identifying a path forward for the reconciliation package for fiscal year 2026. He also provided a comprehensive update on the ongoing efforts of the Trump administration, particularly focusing on the Department of Transportation (DOT). He mentioned that the administration was eliminating staff agencies through layoffs and was urging DOT staff to finalize discretionary grant programs. He also discussed the Secretary's testimony before the Senate Environment and Public Works Committee regarding transportation reauthorization. He highlighted the commitment to expediting project delivery and the need for permit reform. Lastly, he mentioned the release of the first major notice of funding opportunity under the Trump administration for the Safe Streets and Roads for All program. The conversation ended with a discussion on how members of the Regional Council can participate in lobbying trips to Washington and Sacramento.

#### **BUSINESS REPORT**

---



Regional Council member Lucy Dunn reported that her business report was on page 136 of the agenda packet. She discussed the economic benefits of ports and the importance of rebuilding properties quickly. She also mentioned the formation of a private sector group called Steadfast LA and the potential for a list of private sector helplines. She highlighted the challenges of insurance rates and the need for Commissioner Lara to make the right decision. She also discussed the impact of tariffs on businesses and the need for internal recession planning. She encouraged local governments to consider opportunities for growth and to partner with the business community.

Regional Council Member Mike Goodsell, ICTC, discussed challenges in the insurance industry, warning of potential rate increases and companies leaving California.

Regional Council Member Karen Spiegel, Riverside County, raised concerns about insurance companies terminating policies for arbitrary reasons.

#### **PRESIDENT'S REPORT**

President Hagman noted that the conversation of insurance was currently a huge topic. He expressed that he thought there was a role to play for them as local government in the discussion.

#### **EXECUTIVE DIRECTOR'S REPORT**

Executive Director Ajise provided an update on the Climate Pollution Reduction Grant Agreement and noted that they had just approved the acceptance of \$50 million in sub-Award from the SCAQMD which would expand SCAG's LMFP. He indicated that this sub grant recipient status would allow them to use the \$50 million to enable more class 4 and 5 battery electric vehicles in their LMFP through a rebate process. He noted they would bring more information as they got agreements in place. He also thanked the Regional Council for their approval of the 2025 Regional Active Transportation Program. He noted that they would submit the program to the California Transportation Commission for adoption in June. He also expressed that they looked towards moving forward with this plan for \$35 million to support 15 projects and another \$972 million for 113 contingency projects – all of which support walking, bicycling, and other forms of active transportation in the region. He reported that STBG/CMAQ, a \$1.2 billion call for projects, opened March 31. He noted that the projects eligible for this program were being funded over two fiscal years. He also explained that SCAG and their County Transportation Commissions hosted a total of seven workshops to support grantees in preparing their applications. He indicated that applications were due through May, and they would bring those recommendations to the Regional Council in December 2025. He also reported that they had a visit with Commissioner Lara to talk about the insurance issue. He indicated that the Commissioner was working hard to bring back insurance companies to write policies in California. He also shared that the Commissioner had

indicated that he had potential funding for climate resilience districts. He also shared that Commissioner Lara was working with Assemblymember Calderon on AB 888 to create the California Safe Homes Grant Program. He noted that the Go Human program was recognized last month with the Eureka! Award for Regional Excellence by the California Association of Councils of Governments at its annual Regional Leadership Forum. He shared that Immediate Past President Jan Harnik and Chief of Government and Public Affairs Officer Javiera Cartagena were in Sacramento to receive the award and made brief remarks. He also congratulated Regional Councilmembers Cindy Allen and Thomas Wong, who were recognized as Elected Official of the Year in their respective LA County Supervisorial Districts at the 2025 BizFed Awards on March 21.

#### **FUTURE AGENDA ITEMS**

There were no future agenda items.

#### **ANNOUNCEMENTS**

President Hagman also noted that he hoped to see everyone at the General Assembly in Palm Desert. He indicated it was a good opportunity to network.

#### **ADJOURNMENT**

There being no further business, President Hagman adjourned the meeting of the Regional Council at 1:33 p.m.
